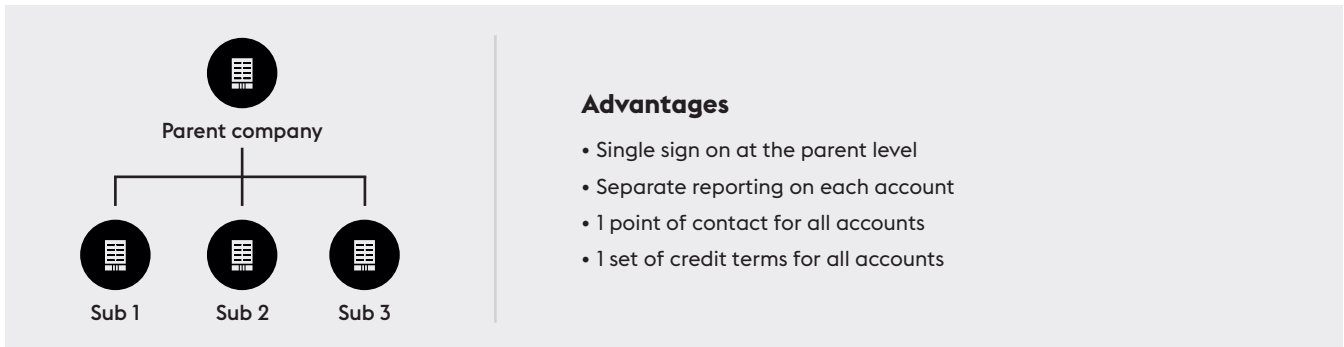

This means you can manage international payments centrally without requiring each subsidiary to sign its own T&Cs with Western Union Business Solutions.

- The sub-accounts carry the name of both the parent and of the subsidiary
- Each sub-account can be reported on separately
- Western Union Business Solutions can accept settlement from subsidiaries bank accounts



Are all subsidiaries eligible?

To qualify for the integrated subsidiaries model, you must be able to demonstrate:

1. A minimum 50% direct or indirect ownership of your subsidiaries.
2. Authority to manage treasury flows on behalf of your subsidiaries.
